

TERMS AND CONDITIONS FOR RUANG RAYA SNAP & WIN CONTEST

1. Duration

- 1.1 This Snap & Win Contest (“**Contest**”) by Nippon Paint (M) Sdn Bhd (“**the Organizer**”) will commence on 12:00 a.m. (local time) on 1st April 2020 and will end at 11:59 p.m. on 30th June 2020 (“**Contest Period**”)
- 1.2 The Organizer may, at its sole and absolute discretion, extend the Contest Period at any time without any prior notice to any party (“the Extended Period”). Unless an Extended Period is announced, all entries received after the end of the Contest Period (due to any reason howsoever and/or whatsoever arising) shall be disqualified. Any participation in the Contest during the Extended Period (if any) shall be governed by these terms and conditions, (“Terms and Conditions”) which shall remain in full force and effect.
- 1.3 By joining this Contest, you agree to be bound by the Terms and Conditions, which are regulated by the Organizer.

2. Eligibility

- 2.1 This contest is open to Malaysian citizens with valid identification numbers (NRIC) and who are aged 18 years and above (as of 1st April 2020).
- 2.2 The Organizer’s employees and immediate family members, related companies, agencies, appointed distributors, dealers and business partners are not allowed to participate in this Contest.
- 2.3 The Organizer reserves the right to reject any entries or disqualify any participant without assigning a reason.

3. Contest Mechanics

- 3.1 Participants are required to purchase Nippon Paint products (excluding Matex Series) in any Nippon Paint authorized dealer during the Contest Period.
- 3.2 After purchase of paints, participants are required to use the purchased paint to makeover their Ruang Raya at home and snap a photo.
- 3.3 Participants then have to send the original photo (unedited) together with the proof of purchase (receipt) and their details (name, NRIC No. and mobile number) via WhatsApp to +6010-833 1881 during the Contest Period.
- 3.4 Once the participants have completed the steps listed above, they will be deemed a participant of the Contest. No entry form is required.
- 3.5 Entries submitted must not allude to or contain, including, but not limited to, the following:
 - 3.5.1 Advertising for other products, services or websites apart from Nippon Paints products; and
/ or
 - 3.5.2 Copyrighted or trademarked material belonging to a third party.

4. Contest Prizes

- 4.1 The Contest will have a total of twenty (20) winners, and each winner will receive RM500 worth of cash.
- 4.2 The Organizer reserves the right to substitute any of the prizes with items of equivalent value without prior notice.
- 4.3 All Contest winners must abide by the Terms and Conditions of the parties arranging and/or providing the prizes and the terms and conditions attached to the prizes, if any.
- 4.4 The Organizer makes no warranty or representation whatsoever with respect to the prizes, and shall not be responsible nor liable for any problems and/or damage arising.
- 4.5 In the event a Contest winner(s) chooses not to accept the prize, they will disclaim all rights, interests and claims to that prize and the prize will be dealt with according to the sole and absolute discretion of the Organizer.
- 4.6 All prizes are accepted entirely at the risk of the Contest winner(s), and the Organizer excludes all liability, representation and warranty in connection with any prize, to the extent that is permitted by law. Contest winner(s) shall comply with the Terms and Conditions of each prize.
- 4.7 All brands, names and trademarks associated with or used to describe some of the prizes are owned by their respective owners. The Organizer and its affiliates are not related to, connected to, or associated with these parties in any way.
- 4.8 Images of the prize used on the promotional materials are for illustration purposes only and do not necessarily reflect the actual prize.

5. Judging/Winning Criteria

- 5.1 In order to win the Contest, the Organizer will select a total of twenty (20) winners after the end of the Contest Period (refer to Clause 4.1).
- 5.2 The Organizer reserves the right to amend and change the Contest's winning mechanics at its sole discretion without assigning any reason whatsoever.
- 5.3 Contest winner(s) will be selected and announced by 31st July 2020.
- 5.4 All the entries will be judged by the top management of the Organizer and chosen the best twenty (20) as the Contest winner(s).
- 5.5 All of the Organizer's decisions in connection with this Contest shall be final, conclusive and binding, and the participants agree to abide by the Organizer's decision regarding all aspects connected with this Contest.
- 5.6 By participating in this Contest, the participants agree not to challenge and/or object to any decisions made by the Organizer in connection with the Contest.

6. Notifications of Contest Winner(s) and Prize Collection

- 6.1 The Organizer will notify the Contest's winner(s) via the official Nippon Paint Malaysia Facebook page and the participants' registered mobile number. Contest winners will be contacted via phone calls to the best of our effort, with a maximum of three (3) attempts. In the event that the shortlisted participant is not contactable after the 3rd call attempt and does not reply via WhatsApp within three (3) working days, a new potential winner will be selected.

- 6.2 The Organizer reserves the right to use any other method or medium it deems fit at its sole and absolute discretion for the purposes of contacting and/or announcing the Contest winner(s).
- 6.3 The Organizer, its partners and its sponsor(s) (if any) will not be held liable in the event of not receiving or delayed delivery of the notification to the Contest winner(s).
- 6.4 The Organizer reserves the right to appoint a third party to conduct the verification of the Contest's winner(s) and the Contest winner(s) agree and authorize that the Organizer may provide all necessary information regarding winning mechanics to such third party for the aforesaid purposes.

7. Publicity

- 7.1 The Organizer shall reserve the right to publish, use the names and/or copies of the Contest winner(s) as material for advertising and/or trade publicity purposes, without any prior notice to the Contest winner(s), and the Contest winner(s) shall not be entitled to claim ownership or other forms of compensation from the Organizer or its affiliates.
